

# SLOUMC Beacon Resurrection Celebration

## Inaugural Art Exhibit - Information for Artists

*Revised 2/17/08*



### *General Comments and Considerations*

Thank you for supporting the Beacon Resurrection Celebration (BRC) Inaugural Art Exhibit. Any medium will be considered for display during the show period, which runs from April 4 through May 11, 2008. All events associated with the BRC Inaugural Art Exhibit will be held at the San Luis Obispo United Methodist Church (SLOUMC), 1515 Fredericks Street, San Luis Obispo, CA 93405. Viewing by the public will be from 9AM until 3PM, seven days a week. Since this is a church, liturgical or religious themed work will receive a more favorable interpretation of acceptable quality and is highly encouraged. SLOUMC will offer a purchase award for the best of show representing a liturgical design. The BRC Art Committee will take a liberal view of the liturgical designs or motifs.

You may submit up to five of your original works of art. Work should be complete, dry, and ready for display/hanging. Two-dimensional works (watercolors, oils, drawings, etc.) should be submitted with appropriate frames and hanging wires. Three-dimensional works (sculptures) should be submitted with a base; and ceramics should be submitted with display stands if desired. The BRC Art Committee will supply no materials other than hanging hooks.

Two-dimensional works shall not exceed 25 square feet and shall not weigh more than 100 pounds. Three-dimensional works shall not exceed 100 cubic feet and shall not weigh more than 300 pounds. The BRC Art Committee reserves the right to make exceptions to these dimension/weight constraints.

By submitting artwork, the artist agrees that SLOUMC is not responsible for loss of or damage to any artwork. SLOUMC will make every reasonable effort to keep artwork safe, but the artist assumes all responsibility for the work during transport, set-up and while on display at SLOUMC. The artist may wish to provide his or her own insurance.

### *Sales*

If artwork is for sale, SLOUMC will assist artists by collecting the sale price (prices may not be changed) and tax of 7.75%. SLOUMC will notify the artist of sales and forward the buyer's check to the artist by mail. SLOUMC will take no commission.

### *Application Process*

Application Form: Submit one application form for each piece of artwork. Use the "Application Checklist" on page four to ensure all requirements are met.

Artist's Information: Include biography, resume, artist's statement and/or show record. We may use some, or all, of the information in the catalog. Additionally, an "artist's statement" binder will be present at the art show.

**Images:** Submit one photo, 35 mm slide, or .jpg image for each piece of artwork entered (an off-white or black background works best when taking photographs). Identify the photo, slide or .jpg with artist's name and artwork title. Tape, attached labels or glass mounts are not acceptable. Images submitted should be of adequate size and resolution to provide the BRC Art Committee with an accurate representation of the artwork. If you want photographs/slides returned, include a self-addressed envelope.

**Entry Fee:** There is a nonrefundable \$5.00 entry fee for each work. Make checks payable to "SLOUMC." Include in the memo portion of your check: "BRC Art Exhibit."

**Delivery:** See the "Application Checklist" on page four.

### ***Acceptance***

This is a juried show. The BRC Art Committee's decision is final. You will be notified by March 19, 2008, if your artwork is, or is not, accepted. The artist gives permission to SLOUMC to use photographs of accepted artwork for publicity or educational purposes. Images of accepted works may be published in the SLOUMC BRC Art Exhibit Catalog. By entering the exhibit, you are allowing us to use photos of your work in our advertising campaigns and catalog.

### ***Delivering Artwork***

Artwork should be delivered on March 26 or 27, 2008, from 9AM until 2PM. Deliver to SLOUMC, 1515 Fredericks Street, San Luis Obispo, CA 93405 and follow the signs to artwork drop and receipt. If you are familiar with the Church, it will be in the Chapel/Library room on the main floor. The BRC Art Committee reserves the right to omit any work from the exhibition if it is inconsistent in quality with the submitted image, is poorly framed, or otherwise has been misrepresented upon actual receipt of the artwork for display.

### ***Opening Reception & "Art After Dark"***

An Opening Reception for artists will be held at SLOUMC on April 4, 2008, from 6PM until 9PM. The Purchase Award will be announced at this time. The opening reception will be held in concert with Arts Obispo, and the San Luis Obispo County Arts Council "Art After Dark" program. Artists are encouraged to attend and mingle with the public. Additional literature will be available for the "Art After Dark" program. The BRC Art Exhibit will also be part of "Art After Dark" on Friday, May 2, 2008.

### ***Retrieving Artwork***

Works of art will be available for pickup by either the artist or purchaser after the show is completed on Sunday evening, May 11, 2008, from 4PM until 7PM, or Monday, May 12, from 9AM until 2PM. If someone else is picking up your work, they need to have written permission from you to do so, and we will require a signed copy. If works of art are not picked up by 5:00PM on May 12, 2008, the artwork will be donated to the United Methodist Children's Center.

#### APPLICATION FORM:

- Complete one application form for each work of art submitted for consideration.

#### ENTRY FEE:

- Include nonrefundable \$5.00 entry fee for each work of art submitted.  
Checks payable to: "SLOUMC." In the memo portion write: "BRC Art Exhibit"

#### ARTIST'S INFORMATION:

- Include biography, resume, show record and/or artist statement. Some of this information will be used in publicity and it will be included in a binder available at the exhibit.

IMAGES: There are two methods of submitting images: digital images or photographs/slides.

- Digital images in .jpg format: Submit via e-mail to [klamoree@sbcglobal.net](mailto:klamoree@sbcglobal.net)
- e-mail subject line must include BRC Art Exhibit and Artist's Name.  
[Example: **Subject: BRC Art Exhibit – Claude Monet** ]
  - file names for the .jgs attached must include the artist's name and title of artwork  
[Example: **Claude Monet – Rouen Cathedral.jpg**]
- Photographs or 35mm slides should be included in an envelope with other application requirements. Identify photographs or slides with artist's name and title of artwork. Include self-addressed envelope if you want photographs/slides returned.  
[Example: **Claude Monet – Rouen Cathedral**]

#### DELIVERY:

- Complete application packages must be received no later than 5:00 PM on March 17, 2008.
- Clearly label the outside of the package: **BRC Art Exhibit.**
